1) **“with mechanical action”** (synonyms: wipe disinfection/by wiping), VAH method 14.2

- a) As concentrate or ready-to-use liquid/solution: Will be diluted to the use concentration by the user and applied immediately thereafter (test according to VAH test method 14.2a)
- b) As wipe dispensing or saturation system⁶ containing dry cloth material as specified by the manufacturer which is saturated with the product solution at the user’s site (test according to VAH test method 14.2b)
- c) As ready-to-use wipes⁷ provided by the manufacturer to the user pre-moistened as immediately ready to use (test according to VAH test method 14.2b)

If the duration of use is to be declared in the certificate of a wipe dispensing system (VIII 1b) for more than one work day; the duration of use must be stated in days after preparation.

Information with respect to A1, A2, A3, B and C, if applicable, will appear on certificates for wipe dispensing systems according to VIII 1b only.

2) **“without mechanical action”** (synonyms: applied by spraying/without wiping), VAH Method 14.1

Note: Products listed “without mechanical action” must not be applied by wiping during the contact time; otherwise they must be tested according to the procedures “with mechanical action” (s. HygMed 2015;40-11).
